A motion was offered by Cory Duplantis, seconded by Jason Connor and duly carried, approving the bills for payment.

A motion was offered by Stephanie Broussard, seconded by Jason Connor and duly carried, authorizing the Mayor to enter into a contract with an electrical engineer for the design of the Energy Efficiency and Conservation Block Grant (EECBG) project (street lighting grant) and to authorize the advertisement for bids once all construction documents have been prepared and approved.

A motion was made by Stephanie Broussard, seconded by Jason Connor and duly carried, adopting a Resolution giving preliminary approval to the issuance of not exceeding eight hundred fifty-five thousand dollars (\$855,000) of grant application notes of the Town of Erath, State of Louisiana, and providing for other matters in connection therewith.

A motion was made by Cory Duplantis, seconded by Mike Richard and duly carried, introducing Ordinance No. 1211 providing for the incurring of debt and issuance of eight hundred fifty-five thousand dollars (\$855,000) grant anticipation note, series 2025 of the Town of Erath, State of Louisiana, and providing for other matters in connection therewith.

A motion was made by Cory Duplantis, seconded by Mike Richard and duly carried, adopting a Resolution giving preliminary approval to the issuance of not exceeding one million three hundred thousand dollars (\$1,300,000) of electric revenue bonds of the Town of Erath, State of Louisiana; and providing for other matters in connection therewith.

A motion was made by Cory Duplantis, seconded by Jason Connor and duly carried, introducing Ordinance No. 1212 authorizing the issuance of one million three hundred thousand dollars (\$1,300,000) of electric revenue bonds of the Town of Erath, State of Louisiana; and providing for other matters in connection therewith.

A motion was made by Stephanie Broussard, seconded by Mike Richard and duly carried, introducing Ordinance #1156 amending Section 8-7(c)(1) changing the way nominees are submitted to the Mayor for appointment of the Fire Chief for the Town of Erath.

A motion was made by Jason Connor, seconded by Cory Duplantis and duly carried, adopting the maintenance agreement between E.J.T.'s Lawn Service, LLC and the Town of Erath beginning December 1, 2025 and ending November 30, 2026.
